Mission of the foundation

The mission of Stichting Capella Sancta Maria is to contribute to the production and performance of musical activities, with a focus on both renaissance and baroque. The foundation supports and promotes two professional ensembles, Capella Sancta Maria and Reina Lupa, which aim to inspire and engage a broad and diverse audience through high-quality performances.

The foundation focuses on the following core activities:

- Musical Performance: Organising concerts both nationally and internationally.
- Cultural Collaboration: Establishing partnerships with other cultural institutions and artists to realise innovative projects and new musical productions.
- Education and Talent Development: Offering workshops and educational sessions for amateur musicians and young professionals, to help develop their musical skills and inspire them to realise their artistic potential.
- Audience Engagement and Diversity: Increasing accessibility to classical and contemporary
 music for a wide and diverse audience through both traditional concert formats and
 innovative presentation methods.

By pursuing these objectives, the foundation aims to make a lasting contribution to the cultural sector and strengthen the role of music in society.

Sources of income

The foundation generates income through:

- Through organising music performances and lectures
- Grants (public and private funding contributions)
- Donations, inheritances and other gifts

Use of funds

The foundation allocates its resources to essential expenses in carrying out its core activities, such as:

- Fees for musicians and other performing artists
- Travel, transport, and accommodation costs
- Venue rental for rehearsals and concerts
- Promotional expenses including photography, (video) recordings, printed materials, radio spots, web hosting, and online campaigns (including on social media)
- Fees for advisory and consultancy services (e.g., support with grant applications)
- Ongoing administrative costs such as banking fees

Asset management

The foundation maintains a business bank account. Its assets consist solely of liquid funds and are not invested.
